The **Certificate in Fundamentals of Investments (CFI)** is a cohort-based blended learning programme for you to gain foundational knowledge about investments and asset management. By the end of the programme, you will:



Gain an understanding of asset management




Develop basic investing and financial analysis skills

Designed for anyone considering a career in asset management and is looking for a flexible and engaging way to learn the topic, this programme consists of 4 modules and is blend of online and inperson learning. Each module comprise of 5 hours of self-paced eLearning via rich multimedia content, interactive scenarios, forums, and quizzes, and 1 hour of contact time with faculty to meet as a cohort, consolidate the learning, discuss key issues, and address queries.

Each module can be taken individually or together. Upon successful completion of all modules, you will be awarded WMI Certificate in Fundamentals of Investments and be invited to Markets Fair, a career networking session with asset management companies.



FEES & FUNDING

This programme is pending accreditation by the Institute of Banking and Finance (IBF). Singaporeans and Permanent Residents will be eligible for funding support of up to 70% course fee subsidy under the IBF Standards Training Scheme (IBF-STS). Singaporeans will also be able to offset remaining course fees using their Post-Secondary Education Account (PSEA) and SkillsFuture Credit.
