

The course provides an overview of ESG and sustainable investing, including investing approaches and challenges in both public markets and private markets investing. Sustainability is a core part of long-term value creation, and involves identifying the repeatable sources of economic return through a holistic understanding of the notion of capital, one that includes natural and human capital in addition to produced capital. The course articulates the ways in which the integration of environmental, social, and governance (ESG) considerations can impact the investment considerations of your stakeholders. Going beyond the fundamental concepts on ESG, the course requires participants to put sustainable investing techniques into practice.

The 'Certificate in Applied ESG Investing and Asset Management' is a two-day program that integrates the different green and sustainable investment approaches and their application to the organisation's portfolio strategies to clients.

Through this course, you will:

- Learn about the ESG investment landscape and how it is evolving
- Understand public markets ESG investing approaches, including ESG portfolio construction and corporate engagement
- Understand private markets ESG investing approaches, including portfolio company management and value creation
- Tackle challenges to ESG adoption such as greenwashing, and map out what it takes to create real change
