Membership Criteria

Associate Membership

- Associate Members would have to comply with the GFO Circle Code of Conduct
- Individuals must either complete a WMI Certification programme or contribute membership fee upfront before their membership is active

Senior Membership

- Senior Members will be expected to contribute to industry development and expertise sharing and should have substantive and direct interaction with family offices in Singapore and the region
- Senior Membership is by invitation only and subject to screening by our Membership Committee

Individuals must either complete a WMI Certification programme or contribute membership fee upfront before their membership is active

Corporate Membership

- This is applicable to leading firm serving family offices, from the private banking, asset management, MFO, trust services, legal, tax, accounting and IFA sectors
- To qualify, Corporates have to nominate at least 2 Senior Members and 5 Associate Members from the firm (or equivalent) and comply with the GFO Circle Code of Conduct
